Visitors

Cookies

Al Tool Usage

We use custom GPT-powered AI tools as part of our services. By purchasing a membership and using these tools through our website, you agree to this privacy policy. We have disabled the setting that would allow OpenAI to use inputs from our custom GPTs for training purposes. Those business partners shall be bound to uphold the same standards of security and confidentiality that we have promised to you in this Privacy Policy, and they will only use your contact data and other Personal Information to carry out their specific business obligations to you and to provide you with website-related services. Family Office Club does not share, sell, rent, or trade your Personal Information with any third parties for their promotional purposes.

We reserve the right to disclose your personally identifiable information as required by law and when we believe that disclosure is necessary to protect our rights or property, to mitigate our liability in an actual or potential lawsuit, to comply with a judicial proceeding, court order, or legal process served on our Website, to enforce this Privacy Policy or our Terms of Use or any other agreement in place between you and Family Office Club, or to investigate and prevent unauthorized transactions or other illegal activities.

Basis for Processing

Family Office Club processes data under this Privacy Policy based on (a) consent of the user as a condition of accessing this Website; (b) the necessity of the data for entering into a contract for Services; and/or (c) the necessity of the data for performing the Services. We are an investor data intelligence research firm focused on single-family and multifamily office companies. We provide helpful, informative research about family offices to our business clients in the investment industry, as well as to non-profits and educational institutions (our "Customers"). Our Customers are organizations seeking business relationships with you or aiming to strengthen existing ones. Our

research is designed to help these Customers gain a better understanding of you, your general and investment interests, and your inclinations: a) so they can assess whether there is a good fit between you and their offerings; b) to help tailor their offerings and initial outreach to connect more effectively with you; c) to improve their communication and services to enhance your experience and ensure it is personalized to meet your needs and expectations.

THE RESEARCH DATA WE COLLECT

For our investor research, we gather data directly from investors, along with publicly
accessible sources including, but not limited to: Public Registers, Trade and
Industry References, Professional Directories, Reliable print and broadcast media,
and internet company websites (we do not use blogs or user-edited content).

Conference attendance information & speakers

The bulk of our research is focused on compiling this publicly available data on single and multi-family office investors.

CATEGORIES OF DATA COLLECTED & STORAGE

The publicly available data we collect about you relates to areas our Customers find helpful in establishing a business relationship with you.

In addition to providing your name and business contact information, we provide your biography, business and investment history, previous places of employment, potential investment areas of interest, past areas of investment, and general location information.

We do not collect any information such as religion, nationality, or political affiliations as outlined in Article 9 of the GDPR.

Upon collection, the data is stored in our database, which is located on a secure server managed and secured by Amazon Web Services (AWS). We take appropriate technical and organizational measures to ensure that your data remains protected. AWS is a leading provider of cloud servers and prides itself on its state-of-the-art security. You can read more about its security practices at https://aws.amazon.com/security/.

Once the data collection is completed, we use it to prepare a commercially-available research offering what we call "investor profiles" that we sell to our Customers.

Our dossiers are distributed to our Customers via a written signed contract that requires that Customers a) use the investor profiles for lawful purpose; b) use the investor profiles for their internal business purpose only; c) maintain the confidentiality of the investor profiles.

Accordingly, we do not broadly publish or disseminate the investor profiles to the public nor do we seek to use the information to embarrass you or harm your reputation. Our goal is to respectfully provide limited access to the investor profiles to a target business audience who can hopefully provide you with a service or offering that appeals to you.

LEGITIMATE INTEREST

As part of our obligation under the GDPR, we have performed a comprehensive review of our data processing activities pursuant to a privacy impact assessment and believe that our processing is justified based on the legitimate interests of our customers and our business; further that such interests are not overridden by your rights and freedoms, particularly given your resources, newsworthiness, and prominence when balanced against the restricted and respectful, narrowly-tailored use we make of your data.

RETENTION OF YOUR DATA

Since we are in the business of providing intelligence-gathering research on the wealthy, so long as you meet our criteria, we will maintain your data in our secure database. Periodically, we will clean up our database and remove data and dossiers that no longer meet these criteria or that we no longer believe is useful.

INTEGRITY OF YOUR DATA

As mentioned above, we use a criteria-based process within our data gathering system designed to ensure data accuracy. Despite these efforts, we cannot guarantee the accuracy of all our records. However, we regularly review the data and make updates when we find or are informed of errors or necessary corrections. Much of the data we collect is historical and does not require updating.

ACCESS AND CORRECTION OF YOUR DATA

If you are in the EU, UK or in a country that provides access and correction rights, we welcome your request to access, correct or update your data that we hold about you. You can request that we delete your information with respect to data that does not meet a lawful justification for processing as well.
